

PORTABILITY

Transferring your Housing Assistance Payment from Brown County to another area is known as Portability. Things to consider prior to moving are: the eligibility requirements, Voucher Payment Standard and bedroom size, and amount of time it will take the receiving Housing Agency to process your case.

WHERE CAN I MOVE TO? Anywhere in the United States or US Territory provided there is a Housing Agency that provides the Housing Choice Voucher Program. You must contact Integrated Community Solutions 60 to 90 days prior to moving to request Portability.

Integrated Community Solutions is the “Initial PHA” when a family requests Portability to move out of Brown County. Our obligations are:

1. To determine the Housing Agency for the area where you are moving,
2. Forward the necessary documents,
3. Reimburse the Receiving PHA if they are unable to absorb your family.

The “Receiving PHA” is the Housing Agency that provides assistance where you are moving and their obligations are:

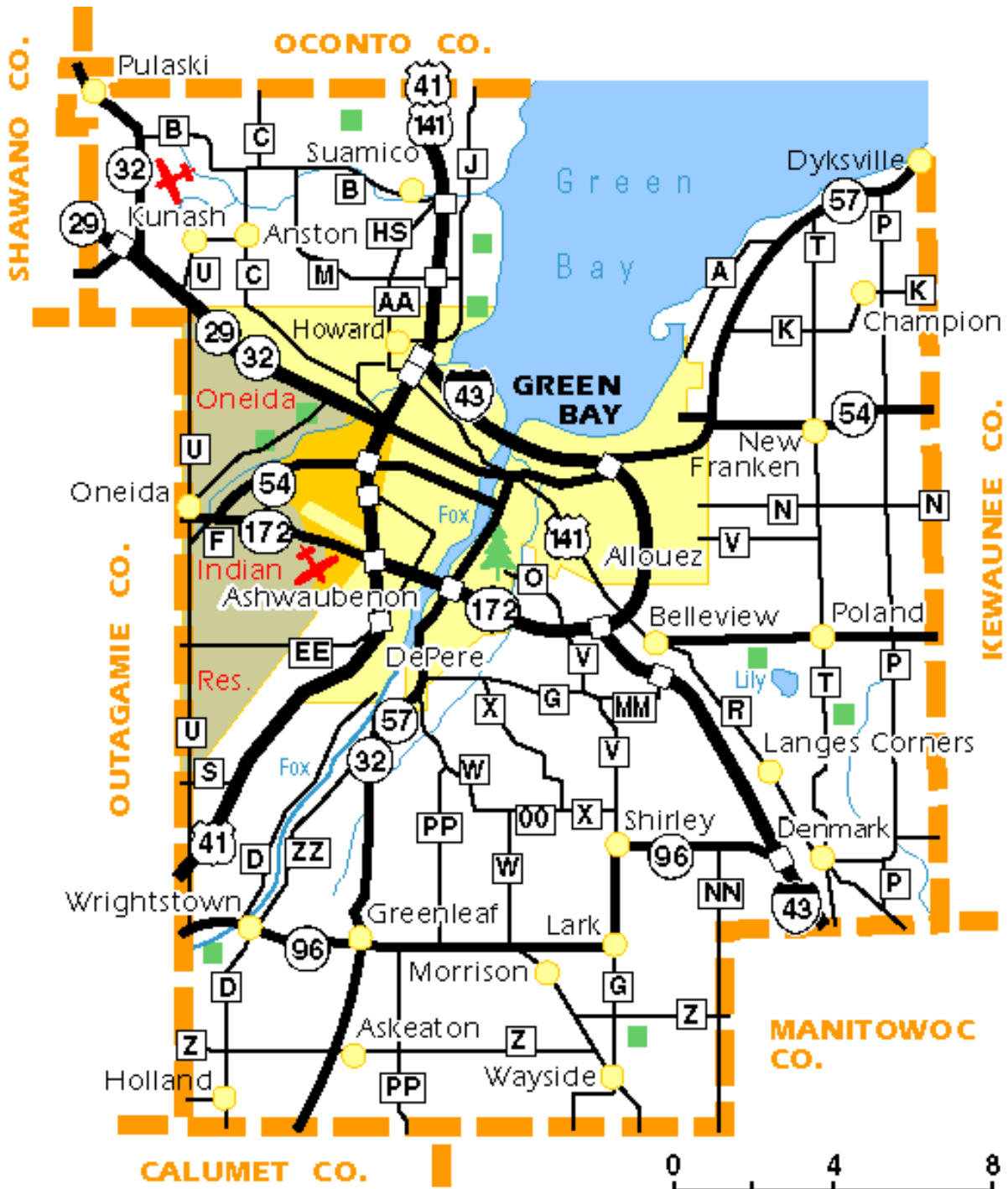
1. To determine if your family meets their eligibility requirements,
2. Accept and reissue your Voucher,
3. To determine if your family will be absorbed or to bill ICS for reimbursement of Housing Assistance Payments made on your behalf,
4. Provide you with the necessary information to locate a new housing unit.

Your responsibilities are:

1. Obtain both the Move Request and Tenancy Termination forms from ICS to complete and submit with a copy of the move notice to your landlord,
2. To promptly contact the Receiving PHA and comply with that agency’s procedures for incoming families,
3. Locate a housing unit and submit a Request for Tenancy Approval form before your Voucher expires.

Once you have moved from Brown County you must comply with the local policies of the Receiving PHA. If you decided to move from that area you must contact the Receiving PHA to assist you with a Request for Portability.

STEPS TO THE PORTABILITY PROCESS

The following items MUST be completed by you and your Specialist before your paperwork can be sent to the Receiving Housing Authority:

- 1. Attend the Initial Appointment and Complete the Move Request Form**
- 2. Attend the Briefing**
- 3. When your Specialist has verified you attended the Briefing, they will process your file and one of the following will happen:**
 - If Verifications of Assets/Income/Allowances are Missing: You will be contacted by mail notifying you of what is needed to process the file
 - If Verifications are In: The file will be given to the Portability Specialist
- 4. The Portability Specialist will fax AND mail paperwork to the Receiving Housing Authority within 2 weeks of the date of your briefing.**
 - You will Receive: A letter stating your paperwork has been sent along with a copy of your voucher and a contact sheet providing the phone number of the Receiving Housing Authority.
 - Keep In Mind: It can take up to 2 weeks for the Receiving Housing Authority to get your information into their system and contact you by phone.
 - Please DO NOT CONTACT the ICS Portability Specialist earlier than 2 weeks from the date you received your letter stating the paperwork has been sent
 - UNLESS you would like to keep your voucher in Brown County, you wish to transfer your voucher to a different Housing Authority or you have moved to a new address earlier than expected.
